Coverage Features

Firms that qualify for our DRI / Defense Firm Endorsement must have 51% or more of their practice dedicated to defense work. These qualifying firms receive a DRI / Defense Firm Endorsement attached to their policy.

The enhancements include:

- Increased limit for disciplinary proceedings, loss of earnings and crisis event
 - **Disciplinary Proceedings**
 - Increased from \$30,000/\$100,000 to \$50,000/\$100,000
 - **Loss of Earnings**
 - Increased from \$500/\$15,000/\$50,000 to \$500/\$25,000/\$50,000
 - **Crisis Event**
 - Increased from \$20,000/\$40,000 to \$25,000/\$50,000
- Subpoena assistance coverage uncapped
- \$50,000 additional defense limit*
- Enhanced “soft” hammer clause from 50/50 to 75/25
- Five less exclusions
- Allowable equity interest in a client increased from 20% to 30%
- 10% reduction in deductible
- 10% reduction in optional ERP percentages
- 10-15% DRI credit applied
